

MAY IT PLEASE THE HEARINGS PANEL:

1. This memorandum is filed on behalf of the Crown.
2. The purpose of this memorandum is to seek directions from the Hearings Panel regarding Mr Stephen Timms' (planning witness for the Crown) appearance at the hearing for the Introduction Proposal. The joint memorandum on behalf of the Crown and the Council regarding the Definitions Proposal dated 10 July 2015 seeks similar directions in relation to Mr Timms' appearance at the hearing in respect of the Definitions Proposal.
3. Mr Timms' evidence for the Introduction Proposal confirms that an agreement has been reached between the Council, the Crown and Te Rūnanga O Ngāi Tahu in relation to the Introduction Proposal.¹ The Crown is satisfied that there are no outstanding points of difference with the Council and the Crown in relation to its submission points and relief on the Introduction Proposal. The Crown has received no notice seeking to cross-examine Mr Timms from any party.
4. In accordance with paragraph 4(b) of the Hearings Panel's Minute dated 22 May 2015, the Crown respectfully seeks direction from the Hearings Panel as to whether it has any questions for Mr Timms. In the event that no questions arise, the Crown respectfully requests that Mr Timms' appearance at the hearing be excused.
