RECORD OF DECISION

Background

1. The Christchurch City Council ('Council') has received one late amendment to submission 2091 and multiple late submissions from the persons listed in Schedule 1 attached (together 'late submitters'). The submissions all relate to the proposals contained in Stage 2 Chapter 6, General Rules and Procedures, section 6.1 Noise, in particular the engine testing noise contours.
2. The closing date for lodging submissions was 15 June 2015. The late submitters have all provided explanations for their lateness which are primarily due to the individuals claiming that the original public notice did not sufficiently highlight the impact the changes will have on their properties.
3. Clause 5 of Schedule 3 of the Order provides that the Chairperson of the Hearings Panel may extend or waive compliance with any time limits specified by or under this Order, except in relation to the time limit specified in Clause 12(2) which relates to completing the Panel's obligation under the Order. Clause 5 also states that the Chairperson of the Panel may accept submissions received after the relevant closing date notified under clause 5 or 7 of Schedule 1.
4. Although the submissions are out of time, the Christchurch International Airport Ltd ('CIAL') is most affected by these late submissions. It is therefore important that copies of the

late submissions are served on CIAL immediately. There is sufficient time for the submissions to be notified and for the opportunity for further submissions before the hearing of Chapter 6 as part of the Stage 3 hearings. There is a pre-hearing meeting scheduled for these matters on Thursday 29 October at 10 am. Notice of the prehearing is available on the Council website.¹ It is recommended that the late submitters and or their representatives attend the pre-hearing.

Decision


5. The receipt of the late submissions from the persons listed in Schedule 1 referred to me for determination, are accepted.
